### NOTICE OF FILING in Case No. 12-2055-TP-ORD Docketing Division (614) 466-4095

You are receiving this message pursuant to the requirements of Executive Order 2011-01K and Senate Bill 2 of the 129th General Assembly, which require state agencies, including the Public Utilities Commission of Ohio (PUCO), to draft rules in collaboration with stakeholders, assess and justify an adverse impact on the business community (as defined by Senate Bill 2), and provide opportunity for the affected public to provide input on the rules.

You are hereby notified of the filing of the Business Impact Analysis prepared by the Commission's Staff in compliance with the Governor's Common Sense Initiative, for rules contained in Chapter 4901:1-8 of the Ohio Administrative Code, pertaining to telephone companies in **Case No. 12-2055-TP-ORD**.

The PUCO's Business Impact Analysis and Staff revised, proposed rules can be viewed under 9-1-1 Service Program: Chapter 4901:1-8, **Case No. 12-2055-TP-ORD** at:

The PUCO is conducting its five-year rule review of the following rules at this time: 4901:1-8-01, 4901:1-8-02, 4901:1-8-03, 4901:1-8-04, 4901:1-8-05, and 4901:1-8-06. Specifically, Staff recommends modifications to Rules 4901:1-8-01 (definitions), 4901:1-8-02 (general provisions), 4901:1-8-04 (records), and 4901:1-8-05 (reporting), O.A.C. The modifications consist of updating the definitions of incumbent local exchange carrier, wireless service, and wireless service provider with more current definitions or cites that were incorporated recently in Chapter 4901:1-6, O.A.C. In addition, the Commission's waiver language contained in the general provisions rule is amended to be consistent with other O.A.C. chapters. Finally, the rules concerning recordkeeping and reporting have been updated to replace the references to Chapter 4901:1-5, O.A.C., which have been repealed, with references to Chapter 4901:1-6, O.A.C. The agency has initially determined that rules 4901:1-8-03 and 4901:1-8-06 need not be changed at this time.

Parties who wish to file initial or reply comments on the contents of the Business Impact Analysis or on the proposed rules should file their responses either electronically or in hard-copy with the PUCO's docketing division in Case No. 12-2055-TP-ORD and copy the Common Sense Initiative Office on your email at [CSIPublicComments@governor.ohio.gov](mailto:CSIPublicComments@governor.ohio.gov) no later than October 10 and October 17, 2012, respectively.
