Re: FTR Energy Services, LLC, Case Nos. 12-150-EL-CRS and 11-5020-GA-CRS

Dear Sir or Madam:

FTR Energy Services, LLC ("FTR") was certificated as a Competitive Retail Electric Service Provider and as a Competitive Retail Natural Gas Marketer, in Case Nos. 12-150-EL-CRS and 11-5020-GA-CRS, respectively. FTR is submitting this letter to comply with Sections 4901:1-24-10 and 4901:1-27-10 of the Ohio Administrative Code, which require competitive retail electric and natural gas suppliers to inform the Commission of material changes to the information contained in their certification applications.

As a result of a September 18, 2012 Exchange Transaction among Public Power, LLC ("Public Power"), FTR's parent, Regional Energy Holdings, Inc. ("REH"), and Crius Energy LLC ("Crius"), changes have occurred to the information FTR provided in its applications. This letter discloses those changes and describes the Exchange Transaction in more detail.

First, FTR notifies the Commission that its business address has changed, effective October 1, 2012, to 1055 Washington Blvd., 7th Floor, Stamford, CT 06901.

Second, FTR has become affiliated with several additional licensed competitive retail electricity and natural gas suppliers that supply these commodities to customers in several states. The new affiliations have materialized as a result of the above-mentioned Exchange Transaction. Specifically, on September 18, 2012, pursuant to an Exchange Agreement, each of the members holding ownership interests in Public Power and the stockholders owning shares of REH contributed a portion (approximately 75 percent) of their interests in Public Power and REH to Crius, each in exchange for 50 percent of the ownership interests in Crius. The Public Power members and the REH stockholders retained 25 percent of their respective ownership interests in Public Power and REH. The Exchange Agreement, thus, effected a transfer of 75 percent of the ownership interests in REH (FTR's immediate parent) to Crius, and the remaining 25 percent of REH is owned by the same entities that owned it prior to the implementation of Exchange



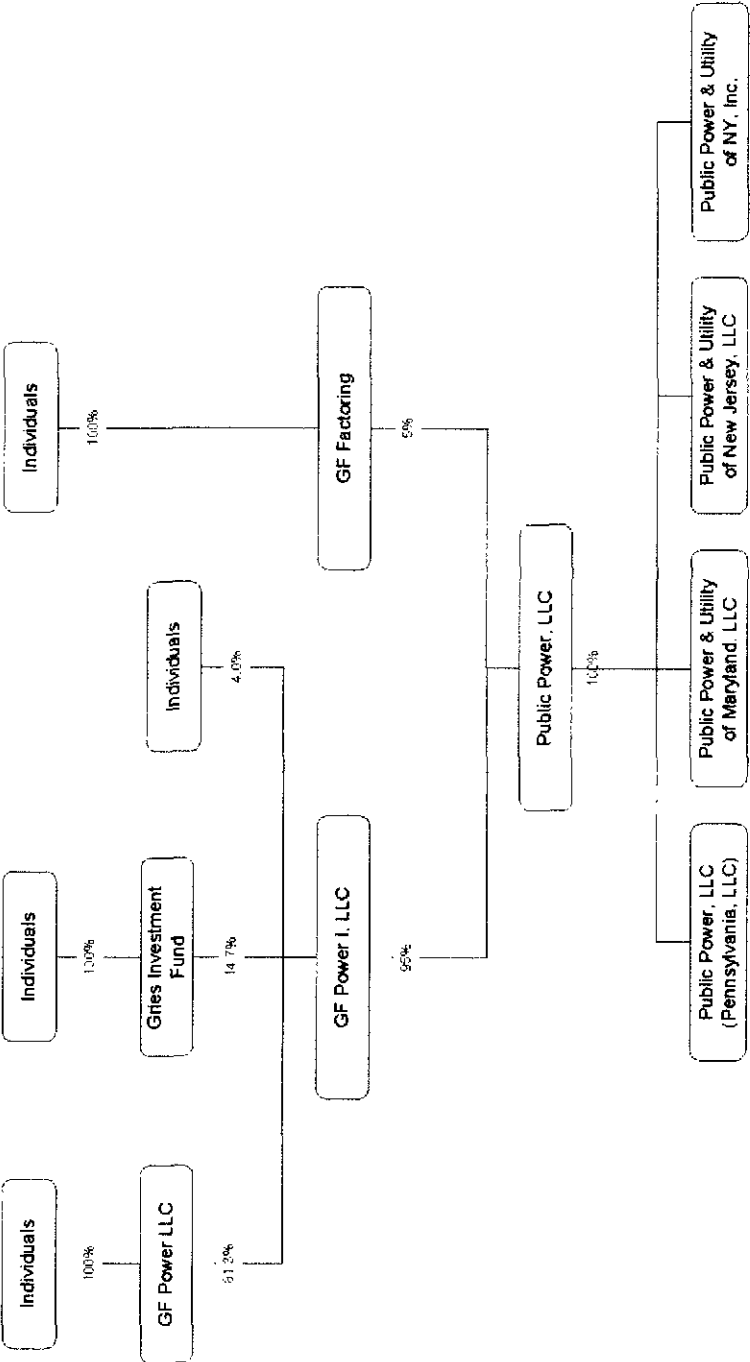

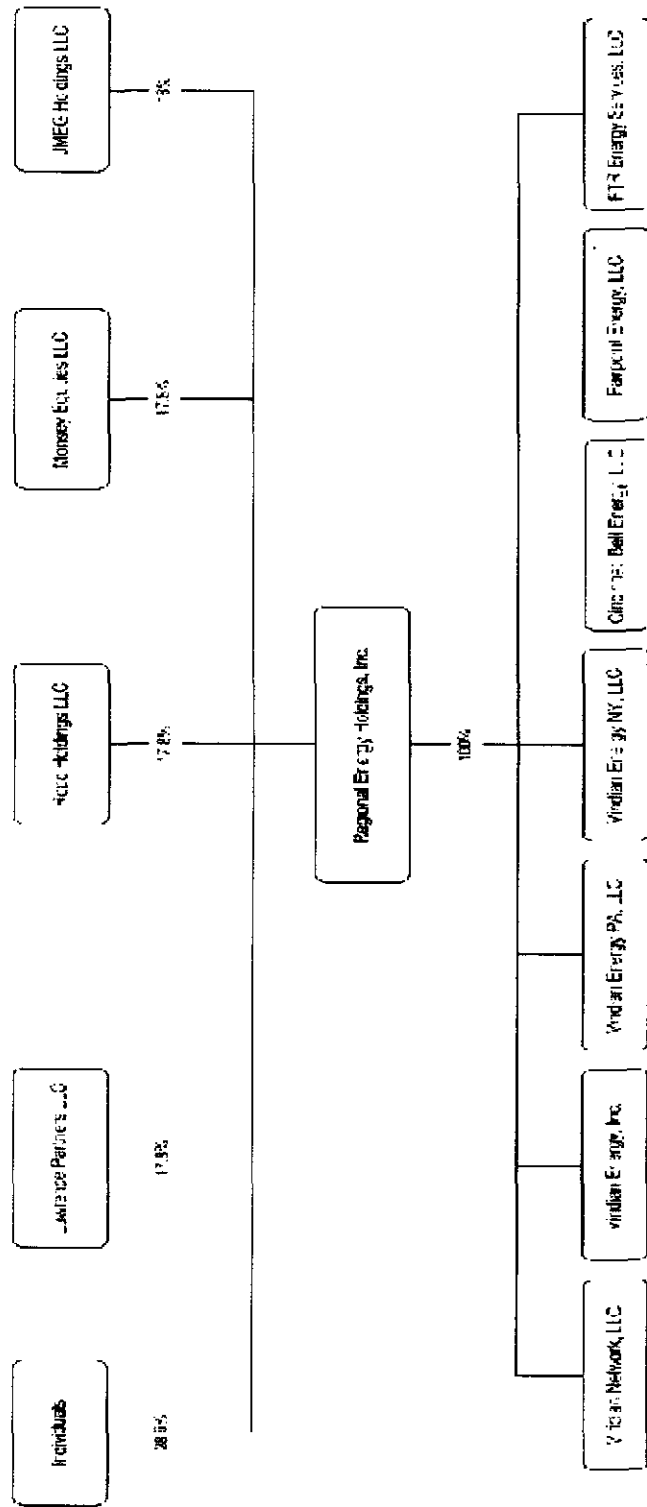
