



A fee is attached to the price that is contracted for from a third party supplier and the fee is then collected and remitted to National Power Source by the third party supplier. National Power Source power source never receives title to the commodity or any of the transportation contracts associated with the delivery of the commodity. National Power Source represents many of the natural gas and electricity retail providers and the client contracts directly with the selected suppliers for all services and commodities.

National Power Source maintains a toll free number for our clients to call if there are any complaints. We also provide on site meetings to respond to any complaints and update the clients on the status of their contracts with third party suppliers.
