>Re case number 12-1682-EL-AIR: The City of Cincinnati has proposed to force Duke Energy to incur the costs for moving its gas and electric lines under the proposed streetcar route. The costs, of course, would be added to our utility bills, even those like me who live miles from the proposed route. I strongly object to this. The streetcar is not economically viable -- if it were, private industry would be financing it. Further, I have talked to the city's engineer, Michael Moore, about the high costs compared to electric trolley busses (which would not require the utilities to be moved, among other advantages). He stated that high initial costs were an advatage of the streetcar because it would be an incentive for the city to continue funding it and trying to make it succeed. With a lot of money already spent, the city would keep putting money into the streetcar rather than give up. Please do not allow the city to continue with this reckless scheme.
