ENTRY

The attorney examiner finds:

- (1) The above-referenced complaint was filed on July 25, 2012. In the complaint, Angela Ba (Ms. Ba) stated that gas service was started fraudulently in her name at her rental property in Miamisburg, Ohio. Further, Vectren Energy Delivery of Ohio, Inc. (Vectren or company) has been unwilling to work with her and direct the collection of the past-due balance on the account to the actual user of the gas service.
- (2) On August 14, 2012, Vectren filed an answer stating either that the company is without sufficient knowledge or information to admit or deny the allegations in the complaint or that the company denies the allegations in the complaint.
- (3) On November 29, 2012, a telephonic settlement conference was held in an attempt to informally resolve this matter. The parties, however, were unable to reach a resolution of the issue presented in the complaint. Further, it appears that reasonable grounds for complaint have been presented.
- (4) Accordingly, a hearing in this matter should be scheduled to begin at 10:00 a.m. on January 31, 2013, in the offices of the Commission, Hearing Room 11-D, 180 East Broad Street, Columbus, Ohio 43215-3793.
- (5) Any party intending to present direct expert testimony should comply with Rule 4901-l-29(A)(l)(h), Ohio Administrative

Code, which requires that all such testimony to be offered in this type of proceeding be filed and served upon all parties no later than seven days prior to commencement of the hearing.

(6) In Commission proceedings, the complainant has the burden of proving the allegations in the complaint. Thus, at hearing, it shall be the complainant's responsibility to appear and be prepared to present evidence in support of the complaint.

It is, therefore,

ORDERED, That a hearing in this matter be scheduled for January 31, 2013, at 10:00 a.m., in Hearing Room 11-D, at the offices of the Commission, 180 East Broad Street, Columbus, Ohio 43215-3793. It is, further,

ORDERED, That the terms of this entry be observed. It is, further,

ORDERED, That a copy of this entry be served upon each party of record.
