ENTRY

The Commission finds:

- (1) This Commission's Opinion and Order, journalized October 3, 2012, authorized the Applicant, Columbia Park Water and Sewer System, to file for Commission review and approval tariffs consistent with that Opinion and Order, and a proposed customer notice.
- (2) On November 29, 2012, in accordance with the Opinion and Order, Applicant submitted for Commission review and approval proposed tariffs, a proposed customer notice and bill format language to bring their bill into compliance with Rule 4901:1-15-23, Ohio Administrative Code (O.A.C.).
- (3) On November 30, 2012, Applicant submitted a corrected version of the notification of customer rights.
- (4) The Commission has reviewed the Applicant's proposed tariff and finds that the Applicant's proposed tariff would produce gross annual revenues not in excess of that authorized in the Commission's Opinion and Order. Therefore, Applicant's proposed tariff is approved.
- (5) Applicant's proposed bill format language conforms with Rule 4901:1-15-23 O.A.C. and is likewise approved. Due to the large quantity of bill stock, the Commission finds that the Applicant should deplete the current supply of bill stock prior to use of the new bill format.
- (6) The Commission further finds that the Applicant's proposed customer notice of the increase in rates is appropriate and should be approved.

It is, therefore,

ORDERED, That the Applicant's tariff, customer notice and bill format language are approved. It is, further,

ORDERED, That the Applicant immediately commence notifying customers of the increase in rates through special mailing. It is, further,

ORDERED, That Applicant is authorized to file in final form, four complete, printed copies of tariffs consistent with the findings of this Entry. Applicant shall file one copy in its TRF docket number 89-7049-WS-TRF (or may make such filing electronically as directed in Case No. 06-900-AU-WVR), and one copy in this case docket. The remaining two copies shall be designated for distribution to the Rates Division of the Commission's Utilities Department. It is, further,

ORDERED, That the effective date of the new tariff shall be a date upon which four complete, printed copies of final tariffs are filed with the Commission. The new tariff shall be applicable to bills rendered on or after the effective date. It is, further,

ORDERED, That nothing in this Entry shall be deemed to be binding upon this Commission in any subsequent investigation or proceeding involving the justness or reasonableness of any rate, charge, rule or regulation. It is, further, 11-5500-WS-AIR

ORDERED, That a copy of this Entry be served upon the Applicant and other parties of record in this case.
