I am emailing you in support of the Turning Point Solar (TPS) project solar array. I am the City Manager of Napoleon, Ohio. The City has from early on been supportive of the over 300 permanent manufacturing jobs this means for our City. The most important consideration for us has always been the commitment that we received, and so far has been kept, that over half of these jobs will be filled by veterans.

I know that we in Northwest Ohio are slowly seeing job recovery; however, when we specifically held a veterans-only job fair for those positions, we had over 150 persons respond. I personally met with these applicants and I promised them that we would do everything we could to find them work. Those efforts continue but TPS represents a significant movement in a positive direction. I believe the merits of the project stand on their own and the veterans issue makes the project just that more attractive for Ohio.

Good afternoon Todd,

Please accept this e-mail of support for the Turning Point Solar(TPS) project scheduled for construction within the Noble Local School District in Noble County. This project is critical to the fiscal welfare of not only the Noble Local School District but to the county as well!

1) TPS represents an extraordinary opportunity to pursue a genuine "all of the above" energy strategy in Ohio, one that literally would see one of the largest solar arrays in the eastern United States constructed in the immediate vicinity of oil and gas drilling;

2) TPS would trigger meaningful economic development benefits in often-overlooked rural parts of Ohio: more than 300 job/years worth of construction-related employment in southeastern Ohio and over 300 permanent manufacturing jobs in northwestern Ohio (over half of which will be filled by veterans);

3) A TPS purchase order for about 250,000 solar panels has compelled Isofoton, a leading European panel manufacturer, to site its North American manufacturing plant in Napoleon, Ohio; a decision to kill TPS would, in all likelihood, lead to the closure of that plant;

4) TPS estimates that close to 85% of the goods and services that will be procured in order to stand up the facility will come from Ohio-based enterprises;

5) TPS represents a unique and productive use of reclaimed mine lands;

6) TPS has received important environmental and interconnection approvals; it is truly a "shovel ready" project;

7) When fully built, TPS will supply totally clean peak power to over 40,000 homes;

8) The cost of solar energy has dropped by 35% in the past two years.

I hope you will look favorably on this project and bring necessary fiscal relief to our school district and to Noble County.

As an individual involved with the Turning Point Solar project over the past years, I wish to express my continued support for the project.

The various benefits of the project have been covered numerous times but continue to remain valid including helping to diversify the state's energy mix, providing jobs in the manufacturing of the solar panels in NE Ohio, providing construction jobs in a traditionally depressed area of the state, providing electricity for up to 40,000 homes and small businesses, becoming more cost effective as the cost of solar panels has continued to decrease, the project can provide a long term site to research the effectiveness of solar in the Ohio climate and gather data that may assist future projects in the state, and taking advantage of the leg work done to date that will make this a project with an immediate impact.

As a local development official let me emphasize some of the benefits accruing to Noble and surrounding counties. The Turning Point project provided the impetus for our county to create the first, and I believe only, alternative energy zone in SE Ohio. This provides our county advantages in working with other renewable energy projects. The payments in lieu of taxes will result in a substantial financial benefit to Noble Local Schools. Chairman Snitchler,

I am writing to underscore support for the Turning Point Solar project, expressed in a letter to you from the University Clean Energy Alliance of Ohio (UCEAO) on October 23, 2012. Recognizing that the case addressing this issue is on the Commission agenda for Wednesday, January 9, UCEAO once again urges the PUCO to move in a positive direction for Turning Point Solar and the continued development of an advanced energy industry that will improve Ohio's environment, create jobs and capital investment, and provide new opportunities at Ohio's colleges and universities.

UCEAO's mission statement places a premium on the "environmentally responsible development and deployment of advanced and renewable energy technologies in Ohio." Utility-scale solar would add considerably to the diversity of the state's generation assets, providing a hedge against fuel price volatility as well as helping address the requirements of the Renewable Portfolio Standard (RPS) established in 2008. From an environmental perspective, it is estimated that TPS will displace significant amounts of criteria air pollutants every year. The installation will be located on 700 acres of reclaimed mine land in Southeast Ohio, putting these lands to a productive use and providing jobs and educational opportunities throughout the State. Given the nature of the technology, TPS will ensure coverage during the summer peaking season, therefore deferring the need for construction of additional generation capacity.

The organization's mission also includes promoting and enhancing connections among Ohio institutions of higher education and the private sector. Turning Point Solar has committed to partner with Ohio colleges and universities in support of both research and education. These partnerships would include workforce training programs in skills directly relevant to the solar industry, as well as opportunities for internships and cooperative education programs. UCEAO shares the state's goal of keeping the best and brightest of our graduates in Ohio. It has been shown that students who participate in on-site learning experiences are more likely to stay in the area, very often at the company that provided the experience.

From an economic development standpoint, TPS has the potential to stimulate growth in several areas of the state. The project site itself will create more than 300 jobs over a threeyear period in Southeast Ohio, an area much in need of employment opportunities. In addition, Isofoton, the Spanish photovoltaic manufacturer, has chosen Napoleon, in Northwest Ohio, as the location for its North American Headquarters, adding to the robust supply chain of Ohio-based companies involved in the manufacture, distribution, design, assembly, operation and maintenance of solar components and systems. As the supplier of more than a quarter of a million panels needed to complete the TPS project, Isofoton's commitment to building this facility and the hundreds of jobs it will generate, is an excellent example of the future of advanced energy manufacturing in Ohio.
