

Dear Chairman Snickler and Chief Policy Advisor Struble,

As we near a final decision on the PUCO cases relating to the Turning Point Solar project I want to once again register the strong support for the project by the Appalachian Partnership for Economic Growth, the JobsOhio Network Partner for Appalachian Ohio.

As I noted in my earlier letter filed with the Commission regarding this case, this is an extremely important project for the people and economy of one of the most depressed areas in our region. Several of the many important benefits to the region include:

- Noble County, which hosts the proposed site, faces very significant economic challenges that the
 project would help mitigate. Through the project's Enterprise Zone, it will add \$400,000 in sorely
 needed annual revenues to local units of government, helping them provide essential services,
 including especially support of the schools in the county.
- The 300 job-years of employment during construction will help mitigate ongoing high levels of unemployment in Nobel County and the surrounding area.
- The employment created will help soak up laid off workers from the Ormet Aluminum smelting operation in neighboring Monroe County layoffs that are partially due to the company's struggle to meet electric rates that are higher than its competitors in this very energy intensive industry.

With its location on a reclaimed former strip-mine site, it demonstrates that environmentally
friendly investments in power can coexist with extractive industries and thrive in areas with a
history of relying on energy extraction as an economic driver.
