

THE PUBLIC UTILITIES COMMISSION OF OHIO

ENTRY

- (1) The Dayton Power and Light Company (DP&L) is a public utility as defined in Section 4905.02, Revised Code, and, as such, is subject to the jurisdiction of this Commission.
- (2) On June 29, 2012, DP&L filed an application to update its Reliability Targets, Customer Average Interruption Duration Index (CAIDI), and System Average Interruption Frequency Index (SAIFI) in accordance with Rule 4901:1-10-10, Ohio Administrative Code (O.A.C.), and the Commission's Opinion and Order in Case No. 09-754-EL-ESS issued on July 29, 2010.
- (3) On July 26, 2012, the Office of the Ohio Consumers' Counsel (OCC) timely filed a motion and memorandum in support to intervene in this proceeding. On October 10, 2012, the attorney examiner granted OCC's motion to intervene.
- (4) Consistent with Rule 4901:1-10-10(B)(6), O.A.C., and in order to accomplish the review of DP&L's proposed reliability standards, the attorney examiner set a procedural schedule in this matter. Comments were filed by OCC on November 20, 2012, and by Commission Staff (Staff) on November 30, 2012. Reply comments were filed by both OCC and Staff on December 20, 2012. OCC argued in its comments and reply comments that the proposed reliability standards are unjust and unreasonable.

- (5) According to Rule 4901:1-10-10(B)(6)(e), O.A.C., if the Commission believes that the proposals in the application may be unjust and unreasonable, it should set the matter for hearing and publish notice of the hearing. The attorney examiner finds that a prehearing conference should be scheduled in this matter for February 5, 2013, at 10:00 a.m., at the offices of the Commission, Hearing Room 11-C, for the purpose of discussing potential dates for hearing and the necessary procedural schedule.

It is, therefore,

ORDERED, That a prehearing conference be scheduled for February 5, 2013, in accordance with finding (5). It is, further,

ORDERED, That a copy of this Entry be served upon all parties of record.
