

Dear Property Owner,

American Transmission Systems, Incorporated (ATSI), a subsidiary of FirstEnergy Corp., is proposing to construct the East Springfield-London-Tangy Transmission Line Project and the London Substation Project (combined, the Project). This letter briefly describes the Project, the Ohio Power Siting Board (OPSB) certification process, and provides you with a notice of the OPSB's date and location of the upcoming public hearing on the proposed Project.

ATSI proposes to construct the Project, a new utility facility, in two Applications submitted to the Ohio Power Siting Board for a Certificate of Environmental Compatibility and Public Need. The proposed Transmission Line Project is located in Harmony and Springfield Townships as well as the City of Springfield in Clark County, Ohio; Canaan, Darby, Deer Creek, Jefferson, Monroe, Someford and Union Townships, as well as the City of London, the Village of Plain City and the Village of West Jefferson in Madison County, Ohio; Darby, Jerome and Mill Creek Townships in Union County, Ohio; and Concord, Delaware, Liberty and Scioto Townships and the City of Delaware in Delaware County, Ohio. The proposed London Substation Project is located in the City of London in Madison County, Ohio.

The Transmission Line Project includes extending approximately 60 miles of new 138 kV overhead electric transmission line in two separate segments between the existing East Springfield and London substations and the between the existing London and Tangy substations.

The East Springfield-London 138 kV line segment will be approximately 20 miles in length depending upon the route chosen and connect the existing East Springfield Substation, located along Alta Rd. in Springfield, to the existing London Substation located along Chrisman Ave. in London, Ohio. This segment can be largely installed on "open arm" positions on existing transmission line towers within an existing right-of-way. Open arm refers to existing transmission line structures that were built to support two transmission line circuits but only have one circuit currently installed. As a result, a second circuit can be installed without adding more towers or increasing the width of the right-of-way. The available open arm position has been proposed as a Common Route, and separate Preferred and Alternate Routes are proposed where an open arm position is not available. As shown on the map, the route will exit East Springfield Substation on the open arm for approximately 0.75 miles. It will then travel approximately 1.5 miles on new wood poles in a new right-of way for either the Preferred or Alternate Route until it once again is installed on the open arm of existing structures. The route then extends east for approximately 17 miles along the open arm position, ending approximately 2 miles west of the London Substation. The remaining

approximately 2 miles will require new wood poles with the Preferred Route utilizing an existing right-of-way and the Alternate Route requiring new right-of-way.

The second segment is approximately 40 miles long, depending on the route that is selected, and will connect the existing London Substation to the existing Tangy Substation located along Bunty Station Rd. in Delaware, Ohio. A Preferred and Alternate Route are proposed for this segment and are shown on the attached map. The Preferred Route for this segment will be installed on new wood poles for its entire length. Nearly all of the first approximately 30 miles of the Preferred Route largely follows existing right-of-way that was previously acquired and currently contains an existing wood pole sub-transmission line. Most of the remaining approximately 10 miles of the Preferred Route follows existing transmission or sub-transmission lines but new or expanded rights-of-way will be required. The Alternate Route will generally require new construction in new right-of-way which would need to be acquired for the Project. Where new structures are proposed to be installed for the transmission line, those structures are proposed primarily as single wood poles in straight sections of the line and two wood poles at angles in the line. These poles will average about 80-100 feet tall. Laminated wood and steel pole construction also may occasionally be utilized.

The proposed London Substation Project is located in the City of London and near Deer Creek, Somerfield and Union townships in Madison County. The Substation Project involves the conversion of the existing London Substation, currently used for the distribution system, to a distribution and transmission switching substation to accommodate the additional transmission line connections. As proposed, the existing London Substation will remain in its present location. Only a Preferred Site for the Substation Project has been proposed and the requirement for proposing an Alternate Site has been waived as the conversion of the London Substation does not require expanding the fence line of the substation or adding additional property.

The location of the Preferred Substation Site and the Preferred, Common, and Alternate transmission line routes and the Preferred Substation Site for the Project are shown on the accompanying map of the area.

In order to construct, operate and maintain the Project, ATSI submitted applications to, and must obtain approval from, the OPSB. The OPSB requires the submittal of a preferred and alternate site for substation projects and a preferred and alternate route for transmission line projects. The OPSB considers many aspects of the project and ultimately decides if the project is needed, and, if needed, on which proposed site and route it should be constructed. The OPSB approval is provided in the form of a Certificate of Environmental Compatibility and Public Need. On May 18, 2012 ATSI submitted the necessary applications to the OPSB. The OPSB reviewed the applications and found on July 20, 2012 that the application filings were complete and addressed all necessary filing requirements. Section 4906-5-08(C)(3) of the Ohio Administrative Code requires the applicant to send a letter describing the facility to each property owner and affected tenant within the planned site or route of the proposed facility and to each property owner who may be approached by the applicant for any additional easement necessary for the construction, operation, or maintenance of the facility. The information in this letter is being provided to you as a property owner or affected tenant on or along the proposed Preferred, Alternate or Common Route of the transmission line or the proposed substation site, as well as to adjacent

property owners that we may approach for additional easements necessary to construct, operate or maintain the Project.

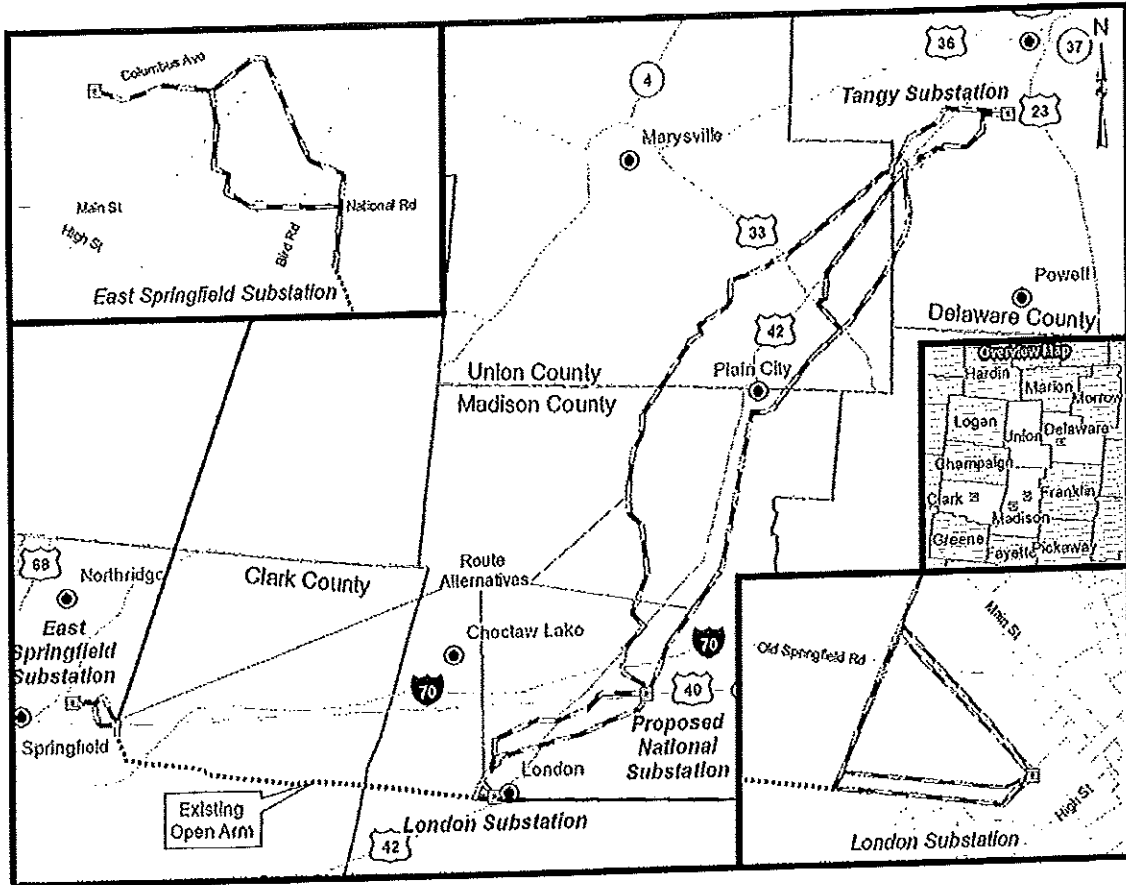



As you may recall, in August 2012 we served you a copy of one or both of American Transmission Systems, Incorporated's ("ATSI") Applications that were submitted to the Ohio Power Siting Board ("Board") for a Certificate of Environmental Compatibility and Public Need for the East Springfield-London-Tangy 138 kV Transmission Line Project and the London Substation Project. On November 5, 2012 the Board's Administrative Law Judge granted ATSI's motion to consolidate these two related projects into one review process. As a part of the Public Notice provisions for the Board's review process for the projects under Section 4906-5-08(C)(3) of the Ohio Administrative Code, we have sent letters describing the facility to each property owner within or contiguous to the right-of-way or planned site of the proposed facility and to each property owner who we may approach for any additional easement necessary for the construction, operation, or maintenance of the facility. The letters briefly describe the certification process, East Springfield-London-Tangy 138 kV Transmission Line Project and/or the London Substation Project, and provide the date and location of the public hearing.

We are also required to submit the name and address of each landowner on the mailing list for these letters to each public official entitled to service of the Application, which we are doing with this letter to you. The subject mailing list is attached and was developed by reviewing the on-line records and contacting the Madison, Union, Delaware, and Clark County Auditor's offices.
