MEMORANDUM IN SUPPORT

In its Entry in these dockets on January 21,2012 the Commission established a procedural schedule which called for the evidentiary hearing to be held on February 19, 2013. That Entry also noted the requirement of Ohio Admin. Code 4901:1-14-08(C) that notice of the evidentiary hearing be published by the natural gas company in a newspaper of general circulation in its service territory as a display ad (or by bill insert or bill message) at least fifteen and not more than thirty days prior to the scheduled date of hearing. The hearing date in these cases is February 19, 2013.

On January 18, Counsel for the Commission Staff filed a motion requesting that the hearing date be rescheduled to April 30, 2013.

The Company has no objection to the motion submitted on behalf of the Commission Staff. Consistent with the rescheduling of the hearing in these cases to April 30, a corresponding extension of the publication requirement in compliance with the above-referenced Rule is clearly appropriate to avoid public confusion.

WHEREFORE, Northeast Ohio Natural Gas Corporation and Orwell Natural Gas Company respectfully request that the foregoing motion for extension of the time for publication of notice of the evidentiary hearing in this docket be granted, so that such notice shall be provided not less than 15 days nor more than 30 days prior to April 30, 2013.
