**MEMORANDUM IN SUPPORT OF THE MOTION FOR CONTINUANCE
OF OHIO POWER COMPANY**

AEP Ohio and Staff filed a Stipulation proposing to resolve the issues in this case on January 23, 2013. Per the Stipulation, an adversarial hearing based on pre-filed written testimony is no longer necessary since the parties reached agreement on the issues presented. It is AEP Ohio's expectation, however, that the Commission would like to have a witness attend the hearing to present the Stipulation, briefly state the reasons supporting its adoption and to make himself available for any questions from the bench regarding the Stipulation. In order to accommodate this alternative process from a scheduling perspective, AEP Ohio requests that the Stipulation hearing be set for February 6, 2013 in lieu of the evidentiary hearing that is currently scheduled.

Accordingly, AEP Ohio requests a continuance of the January 31, 2013 hearing until February 6, 2013 at 9:00 a.m. Counsel for Staff has indicated to counsel for AEP Ohio that Staff

supports this motion. Since there are no other parties, AEP Ohio requests that the Attorney Examiner issue an entry rescheduling the hearing as soon as possible.

CONCLUSION

AEP Ohio respectfully requests that the Commission grant this motion for continuance.
