On behalf of the Applicants, the City of Hamilton and American Municipal Power, Inc., and in anticipation of moving forward with construction, this letter is submitted for docketing to provide notice of information submitted and filed with the Ohio Power Siting staff related to the 138 kV transmission line and associated substation for the Meldahl Hydroelectric Power Project ("Project").
