The Ohio Rail Development Commission (ORDC) has authorized funding for Norfolk Southern Railway (NS) to install active grade crossing warning devices in the City of London, Madison County, as follows:

Oak Street, DOT# 528001U, mast-mounted flashing lights and roadway gates
Maple Street, DOT# 525141L, mast-mounted flashing lights, roadway gates, and cantilevered flashing lights

Madison Road, DOT# 527997Y, mast-mounted flashing lights and roadway gates

These crossings were surveyed on March 16, 2011, as part of the CJ Corridor upgrade, and were found to warrant the new devices.

The projects will be paid for with federal funds, and are actual cost. As the plans and estimates for these projects have been submitted and approved, staff requests an Entry with completion due in nine months. Construction may commence at once. Staff requests that the following language be incorporated in the Entry:

It is expected that all work necessary for FHWA acceptance of the warning devices will be completed by the in-service due date and that the railroad will be responsible for this work. This work includes, but is not limited to:

Any ancillary work to make the warning devices function as designed and visible to the roadway user, and

MUTCD compliance, including minor roadway work if necessary.
