## Man faces charges in Minerva school threat

**MINERVA** About 20 percent of Minerva's High School's student population stayed home from school Tuesday — many due to wintertime illness and others out of fear.

Police Chief Robert First said a man who had been told to stay away from the school returned Monday, alarming students and school personnel.

First said the man uttered the words, "No more high school." Students who overheard were rattled and spread word on Facebook and other social media.

"With that statement, he caused a lot of panic," the chief said.

Kevin Wingert, 51, of Stafford Street, was arrested and booked into the Stark County Jail just before 11 a.m. Tuesday on a felony charge of inducing panic and a misdemeanor charge of trespassing, jail records said.

Superintendent Joseph Chadcock said that Wingert had previously been asked not to come on school property. He declined to provide details.

Chadcock said police and school officials worked through the night Monday and Tuesday morning to ensure students were safe.

At 10 a.m. Tuesday, Chadcock sent an automated call-out to about 2,500 parents and staff members notifying them that the situation had been dealt with and that the man was behind bars. Chadcock said 10 to 15 percent were likely out due to illness, as has been the recent norm. Those who stayed home due to the situation involving Wingert likely numbered 5 to 10 percent, he said.

Wingert remained in the Stark County Jail later Tuesday, held in lieu of \$50,250 bond, jail records said.

## NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio and AEP Ohio Transmission Company (AEP Ohio Transco) propose to improve the transmission system in Stark County by installing a second circuit along its existing Wagenhals-West Canton 138-kilovolt (kV) line.

The purpose of the project is to install a second circuit on the vacant position along the existing tower line. Construction is scheduled to begin in March 2013.

The project is known as the Wagenhals-West Canton 138-kV Line Improvement Project. As required by Ohio Revised Code Section 4906.11-01, AEP Ohio Transco has filed a Letter of Notification with the state of Ohio Power Siting Board.

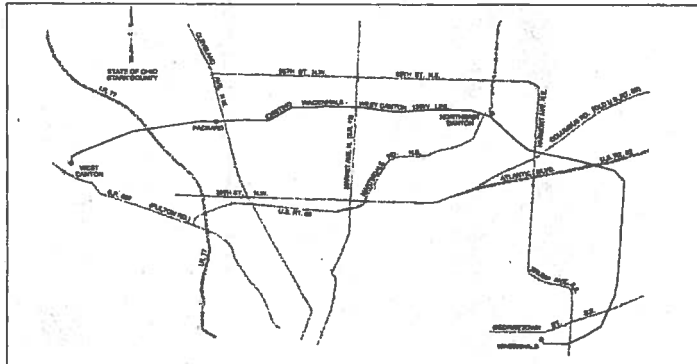
This project qualifies as a Letter of Notification filing because it meets the requirements outlined in OAC 4906.1-01, Item 4(k) of the Interim Application Requirement Matrix for Electric Power Transmission Lines in Appendix A.

The Letter of Notification for the Wagenhals-West Canton 138-kV Line Improvement Project is pending before the Ohio Power Siting Board. This application has been assigned Case Number 13-170-EL-BLN. This number should be included in all communications with respect to this proceeding.

Petitions to intervene in or comment on the Letter of Notification will be accepted by the siting board up to 10 days following the publication date of this notice required by Rule 4906.5-01(C)(1). OAC. Petitions should be addressed to Ohio Power Siting Board, 180 East Broad Street, Columbus, Ohio, 43215-3793 and must cite the above-listed case number.

The Wagenhals-West Canton 138-kV transmission line involves installing a second conductor circuit on an existing tower line that has a vacant position for approximately 10 miles and replacing eight lattice towers with single pole davit arm structures. Because the new conductor will be installed on the vacant side, the project will be located on the existing right of way of the Wagenhals-West Canton 138-kV Line Project.

The substation expansion will be an approximate \$2 million investment by AEP in its transmission system in the area. The project will allow AEP to continue to provide the level of service its customers expect.



The accompanying map depicts the expansion site. It should be noted that due to the reduced scale and limited detail, this map should be used only as a general guide.
