The attorney examiner finds:

- Pursuant to Rule 4901:2-7-12, Ohio Administrative Code (O.A.C.), the Commission Staff served a notice of preliminary determination upon Refix Truck and Trailer Repair, Inc. (Refix), alleging a violation of the Commission's transportation regulations.
- (2) On December 12, 2012, Refix filed a request for an administrative hearing in accordance with Rule 4901:2-7-13, O.A.C.
- (3) Pursuant to an entry issued December 27, 2012, a prehearing conference was held in this matter on January 14, 2013. Shortly after the prehearing conference, the parties established a hearing date of March 11, 2013, and the attorney examiner set the matter for a hearing on March 11, 2013.
- (4) Thereafter, counsel for Refix indicated a conflict with the established hearing date and requested that the hearing be rescheduled.
- (5) The attorney examiner finds that the request to reschedule the hearing date is reasonable and should be granted. Accordingly, this matter shall be set for a hearing on April 10, 2013, at 1:00 p.m., at the offices of the Commission, 180 East Broad Street, 11th floor, Hearing Room 11-D, Columbus, Ohio 43215-3793.
- (6) At the hearing, Staff must prove, by the preponderance of the evidence, that Refix committed the alleged violation, pursuant to Rule 4901:2-7-20(A), O.A.C.

It is, therefore,

ORDERED, That the matter be rescheduled for a hearing on April 10, 2013, at 1:00 p.m., at the offices of the Commission, 180 East Broad Street, 11th floor, Hearing Room 11-D, Columbus, Ohio 43215-3793. It is, further,

ORDERED, That a copy of this entry be served upon all parties of record.
