1 Q. PLEASE STATE YOUR NAME, TITLE, AND BUSINESS ADDRESS.

2 A. My name is David C. Rinebolt. My business address is 231 West Lima Street,
3 Findlay, Ohio 45840. I am the Executive Director of Ohio Partners for Affordable
4 Energy (OPAE), and I appear in this case as a witness on its behalf.
5

6 Q. PLEASE DESCRIBE YOUR BACKGROUND AND QUALIFICATIONS FOR
7 YOUR TESTIMONY IN THIS PROCEEDING.

8 A. My career has covered a broad spectrum of activities in human services
9 programs and the energy industry including policy analysis at both the federal
10 and state levels. I served as Deputy Director of the State of Minnesota
11 Washington Office from 1993 through 1995, focusing on human services, energy
12 and environmental issues. Between 1995 and 1998 I served as Senior Research
13 Associate for Energy with the Coalition of Northeastern Governors Policy
14 Research Center, focusing on low income energy assistance programs and new
15 energy technologies. I also served as Legislative Director for Representative
16 Collin Peterson of Minnesota from 1991 through 1993, and was Director of
17 Programs for the National Association of State Energy Officials from 1994
18 through 1996. I became executive director of Ohio Partners for Affordable
19 Energy in 1996.
20

21 I have a Bachelor of Liberal Study degree with concentrations in
22 Communications, Political Science, English, and Russian Literature (1978) and a
23 Juris Doctor degree from the Columbus School of Law at The Catholic University

1 of American (1981). My professional career has focused on the development,
2 operation and funding of low income energy assistance programs and renewable
3 energy development programs. These concentrations have required a broad-
4 based knowledge of the energy and utility sectors of the U.S. economy.

5
6 I attach my resume as Exhibit DR-1.

7
8 Q. HAVE YOU PREVIOUSLY TESTIFIED BEFORE THE OHIO PUBLIC UTILITIES
9 COMMISSION ("PUCO" or "Commission")?

10 A. Yes. I testified in Duke Energy Ohio Inc.'s Standard Service Offer Case No. 11-
11 3549-EL-SSO, et al, (October 28, 2011) in support of the stipulation and
12 recommendation filed in those cases.

13
14 Q. PLEASE DESCRIBE THE PURPOSE OF YOUR TESTIMONY.

15 A. The purpose of my testimony is to urge the continuation of a fuel fund that has
16 been provided by The Dayton Power and Light Company (DP&L) since 2009. In
17 addition, funding should increase to \$750,000 per year from the existing level of
18 \$400,000 per year because if the increase in poverty and declines in the average
19 household income of poor families in the years since the fund was established.

20
21 Q. PLEASE DESCRIBE THE FUNDING AND OPERATION OF THE EXISTING
22 FUEL FUND.

1 A. The current fuel fund, which distributes \$400,000 per year to assist low income
2 families maintain essential energy service, was originally authorized and funded
3 in Case No. 08-1094-EL-SSO, et.al. The fund was authorized for an additional
4 years at the same funding level in Case No. 11-3002-EL-MER. This will be the
5 final year of the fuel fund if it is not extended.

6
7 Q. PLEASE DESCRIBE THE OPERATION OF THE FUEL FUND.

8 A. DP&L makes an annual contribution Ohio Partners for Affordable Energy
9 (OPAE), a 501(c)(3) nonprofit organization in December prior to the year the fuel
10 fund is made available to families, generally on March 1. Through an agreement
11 between OPAE and the Ohio Development Services Agency (ODSA), formerly
12 the Ohio Department of Development, and an agreement between DP&L and
13 ODSA, funds are made available to eligible customers of DP&L who unable to
14 pay their electric utility bills. Specifically, customers in need of assistance
15 contact one of the community-based nonprofit agencies which receive grant from
16 ODSA to determine eligibility and provide benefits under the Home Energy
17 Assistance Program and the Percentage Income Payment Plan Plus. The
18 customer visits the agency, their household income is verified, and the amount of
19 payment necessary to prevent disconnection or the current bill is authorized.
20 The payment information is entered into the Ohio Community Energy Assistance
21 Network (OCEAN) system, a web-based benefit system utilized to provide
22 assistance for a broad array of social service programs. The client information
23 and payment amount is transferred to ODSA nightly. The information is reviewed

1 and forwarded directly to the DP&L billing system, which credits the payment to
2 the customer's account. ODSA generates a monthly report on the amount
3 benefits provided. OPAE then remits a payment to ODSA in the amount of the
4 benefits. OPAE also pays ODSA an administrative fee of \$8 per client, again on
5 a monthly basis. OPAE receives no funding for its involvement.

6
7 In 2012, over 3,100 customers received assistance from the current fuel fund.
8 The average sum necessary to prevent disconnection was \$129. The benefit
9 has implications far beyond maintaining essential energy services. Beneficiaries
10 are regularly confronted with the need to choose between retaining energy
11 services, eating, or purchasing necessary medicines. It should also be noted
12 that the majority of beneficiaries of bill payment assistance programs are elderly
13 or disabled. A sizeable percentage of the families receiving assistance have
14 children under the age of 5 in the home. And, 90 percent of those obtaining
15 assistance from these programs that can work are working. Unfortunately, the
16 wages they receive are inadequate to cover basic needs.

17
18 Q. CAN YOU PLEASE EXPLAIN WHY THERE IS A CONTINUING NEED TO
19 PROVIDE DP&L CUSTOMERS WITH ASSISTANCE THROUGH A FUEL
20 FUND?

21 A. Poverty remains a significant problem throughout Ohio and in the DP&L service
22 territory. On a statewide basis, poverty increased by 57.7% between 1999 and
23 2011. I have attached a recent publication of the Ohio Association of Community

1 Action Agencies entitled State of Poverty 2012, which provides detailed poverty
2 statistics for each county in the DP&L service territory. Simply put, three years
3 after the beginning of the recession poverty remains a significant problem for
4 families, the elderly and disabled. In most of the counties in the DP&L service
5 territory more than 30 percent of all households are eligible for benefits from the
6 existing fuel fund. The report is attached as Exhibit DR-2.

7
8 Q. WHY IS IT APPROPRIATE TO PROVIDE BILL PAYMENT ASSISTANCE AS A
9 PART OF A STANDARD SERVICE OFFER?

10 A. The Public Utilities Commission of Ohio (Commission) has often issued Orders
11 approving the establishment of fuel funds to assist low income families. All major
12 Ohio utilities are making fuel funds available to their customers this winter,
13 supplementing other federal and state resources. In the case of DP&L, this fuel
14 fund was included and approved by the Commission as a part of the first
15 Standard Service Offer. This is the logical case to continue this important
16 assistance program. In addition, the authorization and funding for the fuel fund is
17 consistent with the policies established by the General Assembly in Am. Sub.
18 S.B. No. 221. Specifically, Sec. 4928.02(L) makes it the policy of the State to
19 “[p]rotect at risk populations, including, but not limited to, when considering the
20 implementation of any new advanced energy or renewable energy resource”.
21 The policies articulated by the General Assembly in the legislation which
22 established the standard service offer should be followed; the continuation of the
23 existing DP&L fuel fund is consistent with those policies and in the public interest.

1 Q. DOES THIS CONCLUDE YOUR TESTIMONY
