

Emuna Energy, LLC is a recognized channel partner of First Energy Solutions Corp. and Duke Energy and will act as the non-exclusive agent of business customers to price out the customer's electricity usage. Emuna Energy also seeks to become channel partners with other certified electric generators so that the customer has numerous pricing proposals to consider. All billing is done by the certified electric generator, as with all collection. In some limited circumstances, Emuna Energy will be the exclusive agent of the business customer for purposes of pricing their electricity usage. Contracts with our customers will delineate whether Emuna Energy is their exclusive agent or whether it is acting on a non-exclusive basis. Emuna Energy will respond to any customer inquiries or complaints in accordance with the Commission's rules.

Since the company began providing services to third parties, we have acted as a broker with respect to approximately 50,000,000 kilowatts of electricity. We currently represent about 20 nursing homes in Ohio, a chain of dry-cleaners, a chain of frozen yogurt stores, numerous office buildings, numerous apartment buildings and approximately 6 million square feet of retail shopping centers. The majority of our services are provided to locations that are north of Columbus, Ohio.

There are no know existing, pending or past rulings, judgments, contingent liabilities, revocation of authority, regulatory investigations or any other matter that could adversely impact the applicant's financial or operational status or ability to provide the services it seeks to be certified to provide.

Applicant does not prepare any annual reports for its members.
