The attorney examiner finds:

- (1) On June 13, 2012, the Commission ordered CSX Transportation (CSX) to install mast mounted flashing lights and roadway gates at the Township Road 33 (538-715L) and Township Road 115 (518-369U) grade crossings, located in Logan County; and ordered Norfolk Southern Railway (NS) to install mast mounted flashing lights and roadway gates at the Township Road 26/Orr Road (481-582H) grade crossing, located in Crawford County. CSX and NS were directed to complete the projects by March 13, 2013.
- (2) On March 4, 2013, CSX filed a request to extend the construction deadline for the Township Road 33 grade crossing from March 13, 2013, to April 13, 2013. CSX stated that the extension request is a precautionary measure due to a possible need for the relocation of the gates and a question regarding the need for a platform on one of the warning devices.
- (3) On March 7, 2013, Staff filed a memo recommending that CSX's extension request should be granted.
- (4) The attorney examiner finds good cause to grant CSX's request. Accordingly, CSX's request for an extension of time, from March 13, 2013, to April 13, 2013, to complete the project should be granted. Staff should continue to monitor the project to ensure it is completed within the newly ordered timeframe.

ORDERED, That CSX's request for an extension of time to complete the project is granted. It is, further,

ORDERED, That CSX complete the Township Road 33 grade crossing project by April 13, 2013. It is, further,
