## AT&T OHIO'S MOTION TO DISMISS

AT&T Ohio<sup>1</sup>, Respondent herein, pursuant to Ohio Admin. Code §4901-1-12, moves to dismiss the captioned Complaint for Complainant's failure to comply with the Entry adopted on February 11, 2013 and for lack of sufficient prosecution. The Complainant failed to timely comply with the February 11, 2013 Entry. On March 12, 2013 the Complainant filed a rambling response that repeats many of the same bizarre allegations that he has made since the inception of this case. Importantly, the response does not mention AT&T's local telephone service, or its practices related to that service, which would be an appropriate subject matter of a complaint.
