**AMENDED MOTION FOR PERMISSION TO APPEAR
PRO HAC VICE OF KAY PASHOS**

Pursuant to Rule 4901-1-08(B) of the Ohio Administrative Code, Christopher Miller, an attorney licensed to practice in the State of Ohio, respectfully moves that Kay Pashos be admitted *pro hac vice* to practice before the Public Utilities Commission of Ohio (the "Commission") for the purpose of representing Duke Energy Ohio, Inc. 
