## **MEMORANDUM IN SUPPORT**

TES requests a thirty (30) day extension of its Certificate No. 11-214G(1) which was issued by the Commission on April 7, 2011 and expires on April 7, 2013.

Ohio Admin. Code 4901:1-27-09(A) provides that a retail natural gas supplier wishing to renew a certificate shall file a renewal application “[n]o less than thirty and no more than one hundred twenty days prior to the expiration date...” As TES filed its Application for Renewal as a Competitive Retail Natural Gas Broker on March 27, 2013, the Commission will not have thirty days to review the renewal application before the expiration date. TES requests a thirty (30) day extension until May 7, 2013, so that its current certification will not expire.

The Commission has previously granted similar requests for extension when a renewal application for certification has been filed less than thirty days before the expiration date. *See In the Matter of the Application of the Village of Fredericktown for Certification to Provide Natural Gas Governmental Aggregation Services in Ohio*, Case No. 09-93-GA-GAG, Entry dated March 18, 2013. TES submits that the basis for the Attorney Examiner to grant this Motion is equally as compelling here as it was in that proceeding.

For all of the foregoing reasons, T.E.S. Energy Services, L.P. respectfully requests that the Commission grant its Motion for a Thirty (30) Day Extension of Certification Expiration Date.
