MOTION FOR CONTINUANCE OF THE HEARING

In accordance with Ohio Adm. Code 4901-1-12(A) and 4901-1-13(A), The East Ohio Gas Company d/b/a Dominion East Ohio (“DEO”) respectfully requests that the Commission continue the hearing scheduled for April 10, 2013, until April 15, 2013. Good cause exists to grant this motion for the following reasons.

DEO currently has two rider cases pending before the Commission: this case, and Case No. 12-3116-GA-RDR, which concerns DEO’s Automated Meter Reading (“AMR”) Cost Recovery Charge. (DEO will refer to these cases as “the PIR Case” and “the AMR Case,” respectively.) The PIR Case is scheduled for hearing on April 10, and the AMR Case is scheduled for hearing on April 15. No party raised any issues regarding DEO’s application in either case, and DEO expects both cases to be resolved by unopposed stipulations. That being the case, DEO expects each hearing to be very brief and to involve no substantive dispute, and thus DEO believes that holding both hearings on the same day will reduce administrative burdens for all parties and the Commission. Likewise, given that DEO’s witness must travel from Cleveland to testify, holding the hearings together will save a day of travel for DEO’s witness.

The only parties to appear in the PIR and AMR Cases are the Commission’s Staff and the Office of the Ohio Consumers’ Counsel (“OCC”). DEO’s undersigned counsel contacted counsel for both Staff and OCC, and neither party opposes this motion.

For these reasons, DEO respectfully requests that the Commission continue the hearing in this case to begin immediately following the conclusion of the hearing in the AMR Case.
