MEMORANDUM IN SUPPORT

This case involves the installation of premium (full-depth rubber) surfaces at the Madison Road and Maple Street grade crossings DOT#s (527-997Y and 525-141L, respectively) and the permanent closure of the West First Street grade crossing (527-998F), and is part of a mini-corridor project which includes signal modifications at three of the City's grade crossings – specifically, the Madison, Maple, and Oak Street (528-001U) crossings. The signal modifications are addressed in a separate Order issued in Case No. 13-347-RR-FED.

Norfolk Southern has initiated the related signal project, and anticipates that the project will be completed within its assigned deadline of November 13, 2013.

With respect to the instant consolidation project, however, Norfolk Southern respectfully requests an extension of time of seventy-five (75) days – through August 6, 2013 – to enable it to complete the requisite bidding process, order and receive the premium material,

install the premium surfaces, and then coordinate with the City to effectuate the physical closure of the West First Street crossing.

The undersigned has discussed this matter with the City's representative, and understands that the City has no objection to this request.
