Mr. Weiss indicated that he was amenable to such a resolution. While the Company believes an agreement among the parties has been reached in principle, additional time is necessary to finalize the agreement. Therefore, the Company requests a two week extension of the deadline for filing its answer in this proceeding to allow the parties additional time to finalize the resolution of the issues raised in the Complaint.
