## **ENTRY**

The attorney examiner finds:

- (1) ASHTA Chemicals Inc. (ASHTA), is a mercantile customer, as defined in Section 4928.01, Revised Code, and obtains electric service from The Cleveland Electric Illuminating Company (CEI). CEI is an electric distribution utility as defined in Section 4928.01, Revised Code, and, as such, is subject to the jurisdiction of the Commission.
- (2) On May 7, 2012, ASHTA filed an application for a reasonable arrangement, in accordance with Section 4905.31, Revised Code, and Rule 4901:1-38-05, Ohio Administrative Code.
- (3) By attorney examiner entry issued February 22, 2013, the attorney examiner scheduled this matter for a hearing to commence on April 24, 2013, with testimony to be filed by April 17, 2013.
- (4) On April 16, 2013, ASHTA and Staff filed a joint motion for a continuance of the procedural schedule in this case, which the attorney examiner granted.
- (5) Thereafter, on May 31, 2013, ASHTA and Staff filed another joint motion for a continuance of the procedural schedule. In their motion, ASHTA and Staff state that business and commercial matters with ASHTA, as well as ongoing discussions with Staff, necessitate additional time to prepare in this matter. Consequently, ASHTA and Staff request that testimony be filed by September 18, 2013, and that the hearing be rescheduled for September 25, 2013. Further, ASHTA and Staff represent that no other party objects to the continuance.
