The Application filed by Duke Energy Ohio, Inc. ("Duke") concerns the implementation of the energy efficiency and peak demand reduction ("PDR") requirements of Senate Bill 221 ("S.B. 221"). Duke's application was filed on April 15, 2013. OAC 4901:1-39-04(D) states, "Unless otherwise ordered by the commission, any person may file objections within sixty days after the filing of an electric utility's program portfolio plan. Any person filing objections shall specify the basis for all objections, including any proposed additional or alternative programs, or modifications to the electric utility's proposed program portfolio plan." No procedural schedule has been filed in this matter, therefore, according to the above cited rule, any objections, proposed additions, alternative programs or modifications must be filed by June 14, 2013.

The undersigned Intervenors, the Ohio Environmental Council ("OEC") and the Environmental Law and Policy Center, ("ELPC") need additional time to review Duke's application and prepare their response. Therefore, the undersigned hereby request an additional two weeks in order to file their objections and any proposed additional or

alternative programs or modifications to Duke's portfolio plan; making objections due on Friday, June 28, 2013. Neither Duke nor any other party has voiced an objection.

WHEREFORE, the undersigned respectfully request the Commission grant OEC and ELPC an extension of two weeks in which to file their respective objections.
