The Commission finds:

- (1) By Opinion and Order issued August 8, 2012, the Commission modified and approved an application for an electric security plan (ESP) filed by Ohio Power Company (AEP-Ohio) in *In the Matter of the Application of Ohio Power Company for Authority to Establish a Standard Service Offer Pursuant to Section* 4928.143, *Revised Code, in the Form of an Electric Security Plan,* Case No. 11-346-EL-SSO (ESP Case), et al. The Opinion and Order as approved, directed the attorney examiners to establish a new docket within 90 days from the order and issue an entry establishing a procedural schedule to allow Staff and any interested party to consider means to mitigate any potential adverse rate impacts from the shift to market based rates.
- (2) On January 30, 2013, the Commission issued its entry on rehearing in the ESP Case.
- (3) On March 27, 2013, the Commission issued its second entry on rehearing in the ESP.
- (4) In order to assist the Commission in its review of potential adverse rate impacts for customers during the transition to market based rates, the attorney examiner finds it necessary to establish a comment process. Staff and any interested party are encouraged to file comments on items, including, but not limited to: cross subsidies among tariff classes; phase-outs of historic rate design mechanisms; methodologies to transition to market based rates; and potential impacts on high winter usage customers. The comment period shall be as follows:
 - (a) July 29, 2013 Deadline for the filing of comments
 - (b) August 19, 2013 Deadline to file reply comments.
