ENTRY

The attorney examiner finds:

- (1) Pursuant to Section 4905.31, Revised Code, and Rule 4901:1-38-05(B), Ohio Administrative Code (O.A.C.), a mercantile customer of an electric utility may apply to the Commission for a unique arrangement with the electric utility.
- (2) On May 10, 2013, Globe Metallurgical, Inc. (Globe) filed an application for approval of an amendment to its unique arrangement with Ohio Power Company (AEP Ohio).
- (3) By entry issued June 19, 2013, the attorney examiner granted AEP Ohio's motion to intervene and set a hearing date for August 6, 2013.
- (4) On July 3, 2013, Globe filed a motion to reschedule the evidentiary hearing and establish a prehearing conference. In support of its motion, Globe explains that there are no outstanding factual issues and an earlier hearing date would avoid unnecessary delay. Globe proposes that a prehearing conference be scheduled for July 10, 2013, and that the evidentiary hearing be rescheduled to July 17, 2013. Globe adds that AEP Ohio has no objection to rescheduling the hearing to July 17, 2013, and does not oppose a prehearing conference.
- (5) The attorney examiner finds that Globe's motion to reschedule the hearing is reasonable and should be granted. Accordingly, the evidentiary hearing shall commence on July 17, 2013, at 10:00 a.m. at the offices of the Commission, 180 East Broad Street, Hearing Room 11-C, Columbus, Ohio, 43215. Further, in light of the fact that the intervention deadline has passed and no comments have been filed in this docket, the attorney examiner finds that a prehearing conference is unnecessary at this time.
