- Jonathan Harrington


Ms. Howell is currently the Corporate Controller for Gas Natural, Inc., the parent company of Northeast Ohio Natural Gas Corporation and Orwell Natural Gas Company ("Companies"). Ms. Howell testified in the prior Gas Cost Recovery ("GCR") cases for these Companies, and intimately familiar with the Companies' management and gas purchasing practices. Mr. Harrington previously held the same position, and has comparable knowledge of the Companies' management practices. Staff respectfully submits that both witnesses are necessary to create an adequate record upon which the Commission can make an informed decision on Staff's recommendations in these cases.

In addition, Staff hereby notifies the parties that it will also call Heather Lipnis, also a former Corporate Controller, and Cindy Bates, Companies' former accountant, to

testify in this proceeding. As both Ms. Lipnis and Ms. Bates are voluntarily testifying as interested fact witnesses, neither requires a subpoena to compel their attendance, and no subpoena is sought.


