Attached is Cincinnati Bell Telephone's (CBT's) tariff filing to revise the month-tomonth rates associated with the 2-way DID channels that are found in CBT's Prime and Trunk Advantage Tariffs. The rate revisions included in this tariff filing are being made as a result of a tariff revision that was inadvertently included as part of a filing that CBT made on January 11, 2000. The January 11th filing decreased the rates of 2-way DID channels for the month-to-month, 36 month and 60 month offerings. CBT did not intend to include the reduction of month-to-month rates in this filing.

With this filing CBT will be revising the month-to-month rates of the 2-Way DID channels back to what they were prior to the January 11th filing. For reasons that were discussed with the PUCO staff on January 27, 2000, CBT will not notify customers of the rate revisions included in this filing. Customers are not aware of the decrease in the 2-way DID rates that were included with the January 11th filing because customer notification is not required for price decreases. In addition, the billing cycle, which would have reflected the revised rates of the January 11th filing, has not yet begun. Therefore, CBT feels that notice would cause confusion among customers since the rates that are being proposed with this filing, are the rates that customers have today.

Pursuant to Section VI.F.7. of CBT's Commitment 2000 Plan, Case No. 96-899-TP-ALT, this filing is scheduled to become effective at the time that CBT publicly files the price changes. Attached are the tariff pages bearing the 96-899-TP-ALT case number in order to implement the price changes. All of the terms necessary to change prices on existing services as detailed in 96-899-TP-ALT have been met.
