6. <u>USE OF SERVICE (CONT.)</u>

.04 (CONT.)

.044 Handicapped Exemption - Handicapped Customers who qualify for exemptions from Directory Assistance Charges due to visual or other physical disabilities will be required to submit a written letter of verification to MCI. Each Directory Assistance billed call will appear on the subsequent month's bill as a credit.

.045 Residential impaired customers or impaired members of a customer's household as defined in Section 1 of this tariff, upon written application and upon certification of their impaired status, which is evidenced by either a certificate from a physician, health care official, or state agency, or a diploma from an accredited educational institution for the impaired, are eligible to receive a discount off their message toll service rates, and, if they utilize telebraille devices, they are eligible to receive free access to local and intrastate long distance directory assistance. Additionally, lines maintained by non-profit organizations agencies, written governmental application upon verification that such lines are maintained for the benefit of the impaired, are eligible to receive a discount off their message toll service rates. Upon receipt of the appropriate application, no less than a straight 70 percent discount off the company's current, price list, day rates for basic message toll service shall be made available, on a 24-hour a day basis, for the benefit of the impaired.
