- (1) The Dayton Power and Light Company (DP&L) is a public utility as defined in Section 4905.02, Revised Code, and, as such, is subject to the jurisdiction of this Commission.
- (2) On June 29, 2012, DP&L filed an application to update its Reliability Targets, Customer Average Interruption Duration Index (CAIDI), and System Average Interruption Frequency Index (SAIFI) in accordance with Rule 4901:1-10-10, Ohio Administrative Code (O.A.C.), and the Commission's Opinion and Order in Case No. 09-754-EL-ESS issued on July 29, 2010.
- (3) Consistent with Rule 4901:1-10-10(B)(6), O.A.C., and in order to accomplish the review of DP&L's proposed reliability standards, the attorney examiner set a procedural schedule in this matter. Comments were filed by the Office of the Ohio Consumers' Counsel (OCC) on November 20, 2012, and by Commission Staff (Staff) on November 30, 2012. comments were filed by both OCC and Staff on December 20, 2012. OCC in its comments and reply comments argued that proposed reliability standards unjust are and unreasonable.
- (4) On February 5, 2013, a prehearing conference was held in this matter to discuss potential hearing dates.
- (5) On July 16, 2013, a stipulation signed by DP&L and Staff was filed in this case.
- (6) The attorney examiner finds that this matter should be set for hearing. Accordingly, the hearing should be scheduled for August 8, 2013, at 10:00 a.m., at the offices of the Commission, 180 East Broad Street, 11th Floor, Hearing Room D, Columbus, Ohio 43215.
