Project Description

The Montgomery County Engineer has plans to widen and reconstruct a portion of Spring Valley Pike and Clyo Road in Washington Township, Ohio. The Montgomery County Engineer has requested that Dayton Power and Light (DP&L) permanently relocate 1,950 feet of 138 kilovolt (kV) transmission line in order to accommodate the road reconstruction project.

Site Description

The transmission line relocation will consist of removing seven (7) existing transmission poles and relocating six (6) of the poles with one (1) pole being replaced but remaining in its existing location along Spring Valley Pike and Clyo Road. Additional right-of-way easements will be required in order to accommodate the pole relocation.

Capital Costs

The capital cost for this project is estimated at \$202,000.

Need

Approximately 1,950 feet of DP&L's 138kV Sugarcreek to Centerville transmission line is located within the project limits. Since the existing alignment of the 138kV transmission line conflicts with the proposed design of the road reconstruction, the poles will have to be relocated.

Nature of Impacts

Minimal vegetation management will be required. If needed, standard practice of mowing would be used to clear vegetation for access. Access to the existing and proposed pole relocation will be from existing public road right-of-way.

The area of the transmission line is mostly light residential. Access along the line corridor will be from crossing public/private roads. Access routes across the DP&L easements or other land along the project area would be coordinated with the property owners. Additional right-of-way easements are required for this project. The Applicant has stated that signed agreements with property owners will be in place prior to any construction activity.

The Applicant has submitted its tree trimming and removal plan. DP&L has indicated that they do not plan to start any tree trimming and/or clearing work until October 1, 2013.

Condition

The Applicant shall adhere to seasonal tree cutting between September 30 and April 1 for removal of suitable Indiana bat habitat, if avoidance measures cannot be achieved.
