1 MR. SAUER: Thank you, your Honor. On  
2 the behalf of the residential customers of Vectren  
3 Energy Delivery of Ohio, the Office of the Ohio  
4 Consumers' Counsel, Bruce J. Weston, Consumers'

11 MR. CAMPBELL: We have a Stipulation.  
12 Your Honor, I don't know if that's considered  
13 preliminary, but the case has been resolved, and I  
14 believe we'll be unopposed by OCC.

7                   the Stipulation as Joint Exhibit 1.
