REPLY COMMENTS

In accordance with the procedural entry of June 12, 2013, The East Ohio Gas Company d/b/a Dominion East Ohio (“DEO”) hereby files its reply comments to the comments and recommendations filed by the Commission’s Staff.

The Staff recommended approving DEO’s application subject to two recommendations. Its first recommendation is that the Commission should “acknowledge DEO’s commitments [set forth in its Application] and indicate its approval of DEO’s Application in this case is conditioned on those commitments.” (Staff Comments at 10.) Staff also states that the Commission should “indicate that . . . recovery of the deferrals is not guaranteed and will be considered in a future proceeding.” (*Id.*) DEO does not oppose the recommendation that it should be held to the commitments made in its Application, and it does not disagree with Staff’s statement that recovery of the deferrals is not guaranteed.

Staff’s other recommendation is that “the Commission direct that DEO’s April 30, 2014 and future annual informational filings should include revenue data from all potential sources of revenue delineated in the incremental revenue formula adopted in Case No. 11-6024-GA-UNC.” (*Id.* at 12–13.) DEO does not oppose including in its annual informational filings a more detailed calculation of incremental revenue in accordance with the adopted formula, and it will

work with Staff to ensure that the appropriate data is included in the April 30, 2014 informational filing.

Given that there is no disagreement between DEO and Staff, and given that both parties recommend approval, DEO would respectfully request that the Commission approve DEO's Application.
