MEMORANDUM IN SUPPORT

Applicant initially applied through Case No. 09-605-GA-AGG for a Competitive Natural Gas Aggregator/Broker certificate, and that application was granted effective on August 20, 2009. Further, Applicant applied for a Renewal of said Certificate on or about July 20, 2011, and that renewal application was granted as Certificate No. 09-158G(2), effective from August 30, 2011 to August 30, 2013.

Applicant initially applied through Case No. 09-604-EL-AGG for a CRES Power Aggregator/Broker certificate, and that application was granted effective on August 20, 2009. Further, Applicant applied for a Renewal of said Certificate on or about July 20, 2011, and that renewal application was granted as Certificate No. 09-169E(2), effective from August 30, 2011 to August 30, 2013.

Applicant moved to a new office location a few months ago, and Applicant experienced unexpected turn-over of employees within the recent past. As a result, the expiration date for the Certificates in question were not made known to the company's officers in a timely fashion. As soon as it was realized that the Certificates needed to be renewed, Applicant obtained legal counsel and proceeded forthwith to file this Motion.
