APPLICATION

Now comes Suburban Natural Gas Company (“Suburban”) and respectfully requests the approval of the Public Utilities Commission of Ohio (“Commission”) for authority to revise Section V, Second Revised Sheet No. 6 of its Tariff, Gas Service Interim, Emergency, and Temporary PIP Plan Tariff Schedule Rider (“PIPP”) from the current rate of 0.08713244 per Mcf down to a rate of (0.1865054) per Mcf, which is a refund to customers. In support of this request, Suburban states as follows:

1. It is an Ohio corporation engaged in the business of providing natural gas service to customers in central and northwestern Ohio and, as such, is a public utility as defined by Section 4905.02 and 4905.03, Revised Code.
2. By this Application, and consistent with the Findings and Orders of the Commission authorizing Suburban’s PIPP, Suburban requests authorization to modify its PIPP (Section V, Second Revised Sheet No. 6 of Suburban’s Tariff). *See, e.g.*, Case No. 07-689-GA-AIR (authorizing PIPP). The proposed tariff page, Third Revised Sheet No. 6, is attached as Exhibit 2.
3. Suburban’s current PIPP rider became effective in April 2008 and has not been modified since then. The PIPP rider reflected in Exhibit 2, Third Revised Sheet No. 6, was

determined in a manner consistent with Case No. 07-689-GA-AIR. The proposed rate would result in a refund to customers. Calculations supporting the rate are attached as Exhibit 1.

4. In accordance with the procedure recommended in the direct testimony of the Commission Staff in Case Nos. 88-1115-GE-PIP, *et al.* and the procedure established by Entry dated June 25, 1993 in Case No. 93-1000-EL-EFR, Suburban could implement the proposed PIPP rider on January 1, 2014, on a bills rendered basis, absent action by the Commission.
