**NOTICE OF CHANGE IN OWNERSHIP**

---

Ohio Power Company, successor by merger to Columbus Southern Power Company (“OPCo”) and owner of the Waterford Energy Center, and AEP Generation Resources, Inc. (“AEP Generation”), the intended transferee, respectfully give notice to the Ohio Power Siting Board (“Board”) of an impending change in ownership for the Certificate that was granted in this proceeding by the Board on November 20, 2000. In its Opinion, Order and Certificate, the Board approved the Waterford Energy Center, which is a natural gas-fired, combined-cycle power plant, located in southeastern Ohio, with a generating capacity of 821 megawatts. The plant began commercial operation in August 2003.

OPCo and AEP Generation intend to enter into an agreement whereby all the assets of this project, including the Certificate, permits and other authorizations pertaining to the Waterford Energy Center will be transferred from OPCo to AEP Generation pursuant to the structural corporate separation plan approved by the Public Utilities Commission of Ohio.<sup>1</sup> In accordance with the attached affidavit, AEP Generation pledges to comply with the terms, conditions and modifications contained in the Certificate issued by the Board on November 20, 2000.

1. I am employed by American Electric Power Service Corporation (AEPSC), a wholly owned subsidiary of American Electric Power Company, Inc. (AEP). AEP is the parent company of AEP Generation Resources, Inc. (AEP Generation).

2. I am the Executive Vice President – Energy Supply. As part of my responsibilities, I oversee management of Generation Resources, Inc., the intended transferee for Ohio Power Company's legacy generating assets under the structural corporate separation plan approved by the Public Utilities Commission of Ohio in Case No. 12-1126-EL-UNC.

3. The Darby generating facility in Pickaway County, Ohio (Darby) and the Waterford Energy Center in Washington County, Ohio (Waterford) are among the generation plants to be included in the transfers from Ohio Power Company to AEP Generation at the end of 2013.

4. AEP Generation pledges to comply with the terms, conditions and modifications contained in the Certificate issued by the Board on September 5, 2000 for Darby.

5. Likewise, AEP Generation pledges to comply with the terms, conditions and modifications contained in Certificate issued by the Board on November 20, 2000 for Waterford.
