
**MOTION TO SCHEDULE ADDITIONAL HEARING
AND REQUEST FOR EXPEDITED RULING**

Pursuant to Rules 4901-1-12, 4901-1-13 and 4901-1-14 of the Ohio Administrative Code, Pike Natural Gas Company ("Pike") respectfully moves that the Commission schedule an additional day of hearing in Case No. 13-214-GA-GCR for November 22, 2013 at 10:00 AM in Hearing Room 11-C. Pike asks that the November 12, 2013 hearing in these matters be continued after members of the public from Eastern Natural Gas Company and Southeastern Natural Gas Company offer testimony. The reasons supporting this motion are set forth in the accompanying memorandum in support.

WHEREFORE, Pike Natural Gas Company respectfully requests that the Commission expeditiously schedule an additional hearing in Case No. 13-214-GA-GCR for November 22, 2013 at 10:00 AM in Hearing Room 11-C, that Pike be directed to immediately publish notice via bill message in bills that will be sent to customers prior to November 7, 2013 and that after any public testimony is

received at the November 12 hearing, that the hearing be continued until November 22, 2013 at 10:00 AM.



MEMORANDUM IN SUPPORT

By Entry of January 30, 2013, these three matters were consolidated for purposes of the hearing to be held on November 12, 2013 at 10:00 AM in Hearing Room 11-C. Rule 4901:1-14-08(C) of the Ohio Administrative Code allows natural gas companies to notify customers via bill message or bill insert included with customer bills, but such notice is to be published at least fifteen and not more than thirty days prior to the scheduled date of a hearing. Eastern Natural Gas Company and Southeastern Natural Gas Company complied with this requirement. Unfortunately, due to problems with its billing system, Pike Natural Gas Company was not able to send timely notice of the hearing in its bills. Pike asks that the November 12 hearing be held as scheduled. After any public testimony is received from Eastern and Southeastern customers at the November 12 hearing, Pike requests that the hearing be continued to November 22 at 10:00 AM. Pike respectfully requests that it be directed to send out notice of an additional hearing date to its customers via bill message on or before November 7, 2013. The additional hearing date would be November 22, 2013 at 10:00 AM in Hearing Room 11-C. Pike asks the Attorney Examiner to direct it to immediately begin publishing notice via bill message of the additional hearing date in its bills. Pike asks that all expert testimony and exhibits be introduced at the November 22 hearing along with any public testimony from Pike customers.

The undersigned indicates that he has contacted Assistant Attorney General Steven Beeler with this proposed request and that the Staff of the Commission does not object.
