




## **SETTLEMENT AGREEMENT AND MUTUAL RELEASE**

Tonja Johnson ("Ms. Johnson") and The Dayton Power and Light Company ("DP&L"), having resolved all issues pertinent to a Complaint filed in Public Utilities Commission of Ohio ("PUCO") Case No. 13-1878-EL-CSS involving electrical service at 449 Fountain Avenue, Dayton, Ohio 45405, hereby enter this Settlement Agreement and Mutual Release according to the terms described below.

1. DP&L will transfer a payment of \$630.55 originally credited to the Account No. 0737407002 in the name of Anthony Peagler to the Account No. 0732642169 in the name of Tonja Johnson. This is a one-time credit to Account No. 0732642169 and DP&L expressly reserves all rights to act in compliance with all applicable tariff provisions, rules, Ohio Administrative Code Provisions and Ohio Revised Code Provisions.
2. Account No. 0737407002 in the name of Anthony Peagler will be credited \$1,611.97, and electric service for 449 Fountain Ave. Dayton, Ohio, 45405 will be established in the name of Tonja Johnson under Account No. 0733963944.
3. In exchange for the credits described above, Ms. Johnson will join in a Notice of Settlement and Joint Motion to Dismiss the Complaint filed against DP&L on August 27, 2013 in Public Utilities Commission of Ohio Case No. 13-1878-EL-CSS.
4. The parties hereby release each other from all complaints, claims and/or liabilities relating to the dispute giving rise to the Complaint filed against DP&L on August 27, 2013 in Public Utilities Commission of Ohio Case No. 13-1878-EL-CSS.
