Pursuant to the October 29, 2013 Attorney Examiner Entry, I am submitting the public version of the average cost data for renewable energy credits that Liberty Power Holdings, LLC has retired or will be retiring to demonstrate compliance with its 2012 Ohio AEPS obligations. Liberty Power Holdings, LLC believes that its average renewable cost of data for the 2012 cost year should be protected from public disclosure as a trade secret.
