ENTRY

The attorney examiner finds:

- (1) On October 13, 2011, Dynamic Energy, LLC, filed an application to become a competitive retail electric broker/aggregator in Ohio.
- (2) On November 16, 2011, the Commission issued Certificate No. 11-406E (1) to Dynamic Energy, LLC, to provide retail electric aggregator/broker services. The expiration date for Certificate No. 11-406E (1) was November 13, 2013.
- (3) Ohio Adm.Code 4901:1-24-09(A), provides that a retail electric service provider wishing to renew a certificate shall file a renewal application "[n]o less than thirty and no more than sixty days prior to the expiration date"
- (4) In its motion for an extension, Dynamic Energy, LLC, states that due to an inadvertent oversight, the application for renewal of its certificate was not timely filed and its certificate is due for cancellation. Dynamic Energy, LLC, argues that granting its request for extension of certificate expiration date until its certificate is renewed will allow Dynamic Energy, LLC, to continue to serve its members, if needed.
- (5) The attorney examiner believes that an extension of the expiration date of Certificate No. 11-406E (1) is warranted. The examiner also finds that an extension of the expiration date until March 13, 2014, would allow Dynamic Energy, LLC, sufficient time to file its renewal application and allow the Commission adequate time for review of the application.

It is, therefore,

ORDERED, That the motion for an extension of Dynamic Energy, LLC's certificate expiration date be granted. It is, further,

ORDERED, That the November 13, 2013, expiration date of Certificate No. 11-406E (1) be extended to March 13, 2014. It is, further,

ORDERED, That a copy of this entry be served upon all parties of record.
