MEMORANDUM OF SUPPORT

Clearview hereby requests a thirty (30) day extension of its Certificate Number 12-451E(1) which was issued on or about February 10, 2012. Pursuant to OAC Rule 4901:1-24-09(A), Clearview's renewal application is due to be filed no less than thirty (30) days prior to the expiration date indicated on its CRES Provider Certificate, which is February 10, 2014. Clearview has not yet filed its Renewal Application and requests additional time in order to complete the preparation of its Renewal Application and supporting materials.

Rule 4901:1-24-09(A) provides in pertinent part: "if the provider files such renewal application less than thirty calendar days prior to the expiration date indicated on the certificate, the provider shall file a motion to extend the expiration date on its current certificate for an additional thirty days. Such motion shall be deemed automatically approved, unless otherwise ruled upon by the commission or an attorney examiner within three business days of the filing of the motion." While Clearview is not yet within this thirty (30) day window before its current certificate expires, Clearview will not be able to complete its Renewal Application with supporting materials by January 10, 2014, and wanted to provide the Commission with notice beforehand. Clearview submits that no one will be prejudiced by the thirty (30) day extension requested herein, and the additional time will permit Clearview to properly complete its Renewal Application.

For all of the foregoing reasons, Clearview respectfully requests that its Certificate Number 12-451E(1) be extended automatically for thirty (30) days, until March 12, 2014, as permitted by OAC Rule 4901:1-24-09(A). Pursuant to this Rule, Clearview would until February 10, 2014, to file its Renewal Application with the Commission.
