Worthington Energy Consultants, LLC ("Worthington") respectfully requests that the effectiveness of its Competitive Retail Electric Service Provider Certificate, Number 12-421E(1), be extended until such time as the current certificate is renewed and/or a new certificate is granted. Due to an administrative oversight, Worthington delayed the filing of its application for renewal of its certificate on November 29, 2013, as Ohio Administrative Code ("OAC") Rule 4901:1-24-09(A) would otherwise require. As Worthington's current certificate expired on December 29, 2013, and the Public Utilities Commission of Ohio ("the Commission") has 30 days to review the application for renewal, an extension is necessary to ensure the continuity of certification.

Worthington is an energy market company that provides energy cost management solutions to commercial, industrial, charitable, religious, retail, and governmental entities throughout the State of Ohio. A licensed electricity broker, Worthington utilizes its experience, expertise and relationships with qualified electricity suppliers to assist its client to save on their energy spend in the competitive marketplace.

It is reasonable for the Commission to extend Worthington's certification. See, e.g, In the Matter of the Application of the City of Norwood, Case No. 10-390-GA-GAG (Entry dated May

10, 2012) (Commission granted applicant's motion for extension of expiration date, although the initial expiration date had already passed). Granting Worthington's request for extension of its certification expiration date until its certificate is renewed and/or a new certificate is granted will

allow Worthington to continue to provide its services and avoid the administrative upheaval that

could occur if its certification is not renewed.

Worthington submits that there is no reason or circumstance that warrants suspension or

rescission of its certificate. There has been no material or adverse changes in its financial or

operational status or its ability to continue to provide high quality services to its clients as it

seeks certification. Worthington will continue to provide information regarding Worthington's

activities in Ohio to the Commission as is required by the Commission. Worthington will

continue to comply with all Ohio rules and regulations.

Worthington respectfully request that the Commission extend the current certificate until

such time as the certificate is renewed as to allow adequate time for processing of its renewal

application or a new certificate is granted.
