ENTRY

The Commission finds:

- (1) On December 18, 2013, the Commission issued an Entry concerning the review of Ohio Adm.Code Chapters 4901:1-36, 4901:1-37, and 4901:1-38. The entry established a January 17, 2014, deadline for comments on Staff's proposed rules changes and the corresponding business impact analyses, with a deadline for reply comments of January 24, 2014.
- On January 16, 2014, Ohio Edison Company, The Cleveland (2) Illuminating Electric Company, The Toledo Edison Company, Duke Energy Ohio, Inc., The Dayton Power and Light Company, and Ohio Power Company (the EDUs) filed a joint motion to extend the deadline for filing reply comments, and a request for expedited review of the joint motion. The EDUs contend that with only five business days between the deadlines for filing initial comments and reply comments, such a compressed time schedule may create difficulties, because the rules encompass many subject areas that require different individuals' expertise. The EDUs assert that extending the deadline for reply comments will better ensure meaningful review of initial comments. The EDUs request that the deadline for reply comments be extended to February 7, 2014.

(3) The attorney examiner finds reasonable the request to extend the reply comments filing deadline. However, the attorney examiner notes that in accordance with R.C. 119.032, review of Ohio Adm.Code Chapters 4901:1-36, 4901:1-37, and 4901:1-38 was to have been completed by September 30, 2013. Therefore, to balance the need for timely review of these chapters and the EDUs' concerns for adequate time to examine and respond to initial comments, the reply comments filing deadline shall be extended to January 31, 2014.

It is, therefore,

ORDERED, That the deadline for filing reply comments be extended to January 31, 2014. It is, further,

ORDERED, That a notice or copy of this entry be served upon all investor-owned electric utilities and certified competitive retail electric service providers in the state of Ohio, and the electric-energy list-serve, and any persons of record.
