FINDING AND ORDER

The Commission finds:

- (1) The Dayton Power and Light Company (DP&L) is a public utility as defined in R.C. 4905.02 and, as such, is subject to the jurisdiction of this Commission.
- (2) On December 4, 2013, the Commission issued its opinion and order (Order), adopting the Stipulation regarding DP&L's proposed energy efficiency and peak demand reduction (EE/PDR) program portfolio plan for 2013 through 2015.
- (3) On December 30, 2013, DP&L submitted its proposed tariffs to become effective on February 1, 2014. On February 4, 2014, Staff filed a staff report on DP&L's proposed tariffs recommending that the tariffs be adopted.
- (4) The Commission finds that DP&L's proposed tariff filing on December 30, 2013, implementing the Commission's Order adopting the Stipulation regarding DP&L's proposed energy efficiency and peak demand reduction (EE/PDR) program portfolio plan for 2013 through 2015 should be adopted. Accordingly, the Commission finds that DP&L should file final tariffs consistent with this Finding and Order.

It is, therefore,

ORDERED, That the proposed compliance rates and tariffs filed by DP&L on December 30, 2013, should be approved. It is, further,

ORDERED, That DP&L file, in final form, four complete copies of the tariffs, consistent with this Finding and Order. DP&L shall file one copy in its TRF docket and one copy in this case docket. The remaining two copies shall be designated for distribution to the Rates and Tariffs, Energy and Water Division of the Commission's Utilities Department. It is, further,

ORDERED, That the effective date of the new tariff shall be a date not earlier than the date of this Finding and Order and the date upon which copies of final tariffs are filed with the Commission. It is, further,

ORDERED, That DP&L notify all customers regarding the availability of the new tariffs via a bill message, via a bill insert, or via a separate mailing within 30 days of the effective date of the tariffs. A copy of the customer notice shall be submitted to the Commission's Service Monitoring and Enforcement Department, Reliability and Service Analysis Division, at least 10 days prior to its distribution to customers. It is, further,

ORDERED, That a copy of this Finding and Order be served upon all parties of record.
