ENTRY

The attorney examiner finds:

- (1) By entry issued January 10, 2014, the attorney examiner scheduled a prehearing conference for February 20, 2014, and a hearing to begin on March 13, 2014. At the prehearing conference, the Commission's Staff (Staff) and Holiday Camplands Association Inc. (Camplands Association) stipulated that they would file testimony on March 6, 2014.
- (2) On March 4, 2014, Staff and Camplands Association filed a joint motion to request a two-week continuance of the evidentiary hearing and a two-week extension of the deadline for filing testimony. Because of the approaching deadline and hearing date, the movants requested an expedited ruling.
 - In the memorandum in support of the motion, Staff and Camplands Association explained that negotiations have been productive and that they believe that they are close to a stipulation. Additional time is needed to continue discussions.
- (3) By letter filed March 5, 2014, Staff notes that R.C. 4909.42 provides that an order must be issued within 275 days after the filing of an application for an increase in rates. To accommodate the two-week extension requested in the joint motion, Staff represents that Camplands Water, LLC has agreed to waive its right under R.C. 4909.42 and has agreed to extend the 275-day deadline by 14 days. Staff and Camplands Association do not object to the extension.
- (4) The attorney examiner finds that the joint motion to continue the hearing and extend the deadline for filing testimony for 14 days is well-taken. The request for additional time to reach a stipulation is for good cause and should be granted. Accordingly, the evidentiary hearing shall be continued to March 27, 2014, at 10:00 a.m. in Room 11-C at the offices of the

Commission, 180 East Broad Street, Columbus, Ohio 43215. Staff and Camplands Association shall file testimony by March 20, 2014. By agreement and consent of the parties, the period for issuing an order shall be extended for 14 days to accommodate the continuance of the hearing and the extended deadline for filing testimony.

It is, therefore,

ORDERED, That, in accordance with finding (4), the deadline for filing testimony be extended to March 20, 2014. It is, further,

ORDERED, That the hearing scheduled for March 13, 2014, be continued to March 27, 2014, at 10:00 a.m. in Hearing Room 11-C at the offices of the Commission, 180 East Broad Street, Columbus, Ohio 43215. It is, further,

ORDERED, That a copy of this entry be served upon all parties and interested persons of record.
