AMENDED MOTION FOR PERMISSION TO APPEAR PRO HAC VICE

Pursuant to Rule 4901-1-08(B) of the Ohio Administrative Code and Rule XII (2)(A)(6) of the Supreme Court Rules for the Government of the Bar of Ohio, the undersigned, an Ohio attorney, respectfully moves that William Massey be admitted *pro hac vice* to practice before the Public Utilities Commission of Ohio for the purpose of representing Utilities Analyses, Inc. in the instant matter. This amended motion supersedes the motion filed on March 11, 2014. In support thereof, the undersigned states as follows:

F. Mr. Massey will comply with all applicable statutes, law and procedural rules of the state of Ohio, and the rules, policies and procedures of the Commission, and will be familiar with and comply with the Ohio Rules of Professional Conduct and the Rules for the Government of the Bar.

G. The Ohio Supreme Court has issued PHV #1770-2014 to Mr. Massey.

H. Mr. Massey understands that if this motion is granted, he must file a Notice of Permission to Appear *Pro Hac Vice* and a copy of the Order granting permission with the Ohio Office of Attorney Services within thirty days of the Order.

I. There are no other parties in Case No. 12-684-EL-AGG. It is respectfully requested that this motion be granted expeditiously so that Mr. Massey can file a motion to extend Certificate No. 12-486E(1) on or before March 18, 2014.

WHEREFORE, it is respectfully requested that the Commission or its Attorney Examiner expeditiously grant this motion for permission to appear *pro hac vice* and permit William Massey to appear in this proceeding.

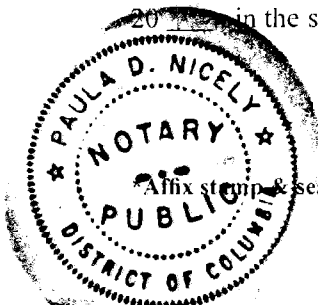


