



A member of the Compliance Division of the Public Utilities Commission of Ohio made a reinvestigation of the customer-owned, coin-operated telephone (COCOT), telephone number 513-233-6254 located at Wayne High School, Filburn Hall 5400 Chambersburg Rd. in Huber Heights, Ohio. In our letter to you on November 5, 1990 we listed eight violations on this COCOT. On our reinvestigation we observed that one (1) violation has not been corrected, as stated below.

Our investigator also investigated eight (8) other COCOTs owned by your company and noted the same violation.

Directory assistance was not free and without the use of a coin. Intralata long distance directory assistance was one dollar.

You were required to correct the deficiencies existing at the locations cited in our November 5, 1990 letter, and you were also required to bring all COCOTs owned by you in the State of Ohio into compliance with the same deficiencies within the same period.

We are in the process of notifying the serving telephone company to disconnect service at the nine locations listed in this letter which have been found to be in non-compliance.

You will be assessed the costs of the Commission's investigations for these nine locations.
